Daughter Jane and David Smith married 22 Feb 2014 in the Old Pecan Street Café Courtyard downtown Austin. The reception @ Old Pecan Street Café Heritage Room two Blocks nearby on 6<sup>th</sup> Street. The Band played Acadian music during the two block move to the Heritage Room and during the Reception.

Jane's Acadian Ancestry in Louisiana: Birth in New Orleans, LA. We adopted Jane through The Volunteers of America (born July 2, 1970). She joined our family 6 days after her birth. We lived in Lafayette, LA 1966-1974 and returned to Houston where we had married in 1963.

Jane's birth mother Sally Savoy, her husband and Jane's half sister and brother attended the wedding. Jane met her birth mother when about age 25. Both had chosen to be Medical Technologists. After approval by Volunteers of America they met in Houston where Sally was employed. The wedding was our first meeting with Sally and her family.

David is a DJ downtown Austin. He was also adopted as an infant born in WI. Jane is a Med Tech @ Seton Hospital North not far from our retirement home. Jane and I worked on his ancestry and found some Smith connections.

Jane's ancestry through Sally goes back to \*Tomas Savoy of Turin, Italy. There was a large rift in the House of Savoy during this time. Son Francois Savoy became an earlier settler in Nova Scotia. Some dispute Francois as a son of Tomas. Francois and other Savoys migrated to Nova Scotia as early settlers. The lines moved to Quebec. See Enclosed Pedigree Chart and Morrison Relationship pages 1 & 2.

Enclosures: Pedigree Chart downward from Tomaso De Savoie to Francois and his wife Catherine Lejeune in Nova Scotia and Relationships of my Hoyt lines down to Sophia Denio who married Elijah Hoyt in Deerfield, MA.

Amelia Morrison may be related to John Wayne.

My relationship to the Savoy lines is through Sophia Denio (1778-1861) and Elijah Hoyt (1778-1802) of Deerfield and later OH (Relationship Chart).

Note the relationship to Benjamin Waite and Martha Leonard (buried in mass Grave in Deerfield). The Waites and Welles lines connect upward in the Plantagenet lines back to William I of England. A Waite married a relative of William I who granted him an estate.

Welles/Waite Relationship: Mary Wells, daughter of Thomas Welles and Mary Beardsley. This Welles line connects the Hoyts with the Waites. Thus connecting with Benjamin Waite and Martha Leonard buried in Deerfield.

My mother's Wells lineage goes back to Virginia during the RW (unable to connect the line back to Wales Welles. My mother was the grand daughter of Elon G. Waite of NY and IA. My middle name is Waite. This line goes back to RI. John Waite married into the Mattesons of RI. Have not been able to prove his parents to clear his ancestry back to England. Am sure he relates to the RI Waites. Three bothers landed in MA mid 1630's. One brother moved on to RI.

Thomas Welles, First Governor of CT relates to my Thomas Wells of CT who

moved on to MA. If my research is correct he would be an Uncle connection.

My Thomas was the father of Mary Wells noted earlier. See chart.

Ancestry.com has greatly improved over the past year or two providing more

basic records to support research. I continue to search for more information to support my findings. Feel free to point out areas needing more research.

Note to John Hoyt April 4, 2014

I drifted off researching the Haute/Hawte lines back to Fitz Haute (1005-?) His son Bertram (1025-?) lived in the Pyrenees-Orientales, Languedoc-Roussillon, France. He died in England.

His son Pierre Fitz Haute (1066-?) was born in France and died in England.

Bertram Fitz Hawte (1180-) was born in England and died in England. Son Thomas (1203-1245)

The DeHawte lines continued with Richard (1220-1319) who married Heiress Margaret De Wadenhake in 1247.

Down line to William Squire Haute (1390-1462). He married Joan Maude 'Wydville' (1409-1462). They had son Sir William Haute, Composer of Music, KG (1430-1497).

Downward to Lady Janette 'Jane' (1522-1600) (Haute/Hawte) married Thomas the Younger Wyatt (beheaded in Tower of London by Queen Mary) Guilty for Wyatt's Rebellion.

Son Richard Waite (1548-?) Lincolnshire, England married Rebecca \*Bowen (1540-1610) Somerset, England had son Richard Waite (1582-1680) who married Margaret Carter 1603 in Alford, Lincolnshire, England. Rebecca may tie with my Bowen Waite lineage. Bowen was the father of Elon G. Waite who had daughter Flora E. Waite who married my grandfather Judson Isaac Wells. He died three years before my birth in 1930.

They had son Thomas Samuel Waite (1601-1665) who married Eleanor Paine (1605-1665) in 1639 in Portsmouth, Newport, RI.

Their son \*Benjamin Waite (1644-1704) married \*Martha Leonard (1649-1704). Son Joseph "Lt" Waite (1688-1780) married Hannah Billings (1696-1716 on 19 Nov 1713.

If the above is credible, the lineage goes downward from Hannah Waite and husband James Porter married in 1737. The Porter lines go downward to Lydia Porter and Abel Allis married in 1769 to Eunice Allis and Elisha DeWolf who married in 1798 my GG grandmother Minerva DeWolf who married Azor Hoyt in 1829 in Franklin, MA. Minerva has enabled a lot of ancestral connections.

The De Hawte/Haute lineage of France likely moved to England following the takeover by William I.

I will forward the lineage following more research.
